Survivor Care Plan Project Team Begins Piloting Survivor Care Plan

Cancer survivors and their health care providers have long expressed a need for reliable and accessible information related to the cancer experience. In response, the Minnesota Cancer Alliance Survivor Care Plan Project Team developed a cancer survivor care plan. Designed to assist cancer survivors who have finished treatment, the tool will help them plan the next phase of their cancer journey.

What's Next?: Life After Cancer Treatment is a 25-page booklet designed to help survivors create a concise history of their cancer treatment experience, manage follow-up medical care, understand short- and long-term side effects, and provide tools and directions for self-care. Most importantly, the tool will provide a platform for dialog between patients and their providers.



The project team is currently obtaining feedback from about 50 survivors across the state. The plan will be revised to reflect suggestions. By 2010, the plan will be available to all cancer survivors and health care providers in Minnesota who wish to use it. American Cancer Society Grant Funds Colorectal Cancer Survivor Care Plan

In collaboration with the Minnesota Cancer Alliance, HealthPartners Research Foundation received a grant from the American Cancer Society to develop a survivor care plan focusing on colorectal cancer. This two-year research project will include obtaining feedback from health care providers and cancer survivors through a needs assessment incorporating perspectives from the underserved. A colon cancer specific survivor care plan will then be piloted and evaluated among survivors and their oncology and primary care providers. Unity Hospital Offers Free Colorectal Cancer Screenings

Allina Hospitals and Clinics, in collaboration with several Minnesota Cancer Alliance partners, provided free colorectal cancer screenings for under- or uninsured Minnesotans on Saturday, May 16, at Unity Hospital in Fridley.

This was the fifth event that resulted from the Minnesota Cancer Alliance Colorectal Cancer Task Force's mission to offer access to underserved individuals. Similar events have been held at Fairview Southdale Hospital in Edina, which hosted two events; Allina's Abbott Northwestern Hospital in Minneapolis; and HealthPartners in Saint Paul.

Services were donated by the Unity Endoscopy Center; Mercy Hospital; Minnesota Gastroenterology, P.A.; Colon and Rectal Surgery Associates, Ltd.; Hospital Pathology Associates, P.A.; American Cancer Society; Colon Cancer Coalition; Minnesota Cancer Alliance; and Minnesota Department Health.

Coborn Cancer Center Offers "Tough Health Care Decisions" Sessions

Recognizing the complex decisions faced by cancer patients and the distress they may cause, Coborn Cancer Center designed "Tough Health Care Decisions" educational sessions. Designed for patients, the community and health care providers, the sessions reiterate the importance of using a systematic approach to decision-making by using the Ottawa Personal Decision Guide. This resource comes after HealthPartners shared its oncology program standards, which encourages the integration of shared decision-making into patient care.

This project supports Cancer Plan Minnesota's objective 12: Improve the quantity of information and support available to cancer patients and providers to provide informed decision-making regarding cancer treatment.

Minnesota Legislature Convenes Cancer Caucus

Formed in spring 2009, this caucus convened to help policymakers better understand cancer. Recognizing that public policy plays a key role in helping eliminate the disease, the caucus' goal is to learn more about patient resources, and in turn help legislators assist their constituents. The idea originated from former State Senator Dan Larson from Bloomington, who is a cancer survivor. Co-chairs are Senator Kathy Sheran (DFL-Mankato); Senator Geoff Michel (R-Edina); Rep. Maria Ruud (DFL-Minnetonka); and Rep. Marty Seifert (R-Marshall). At the request of the Caucus, David Arons, American Cancer Society's director of government relations, serves as the program organizer. The Caucus' next meeting will be this fall.

ACS and Partners Produce Understanding Colon Cancer Videos

The American Cancer Society (ACS) has joined forces with Minnesota's Emergency, Community and Health Outreach (ECHO) and numerous partners to produce a television program to provide information on colon cancer to limited-English-speaking communities. The program aims to create greater awareness of colon cancer, risk factors, prevention and early detection measures and address fear and anxiety around colon cancer screening.

The 20-minute long program, "Understanding Colon Cancer", will air in six languages on Twin Cities Public Television's Minnesota Channel. TPT will broadcast these videos on:
